Entry Fee:	\$400.00 per Team 32 Teams
Weight Classes (Scratch + 2 Pound Growth Allowance):	108, 115, 122, 128, 134, 140, 147, 154, 162, 172, 184, 197, 222, 287 There will only be 1 Weigh-in per team (Thursday Evening or Friday Morning)
Spectator Fee:	\$8.00 per Person \$30.00 Family Rate Kids 5 & Under are Admitted Free
Matches:	Each Team will get 10-12 matches over 2 days (Each team must provide 1 Table Worker/Score keeper for each dual)
Mats:	14 Mats

High School teams or Club Teams are eligible for this event. You may enter more than 1 team into the Tournament but each team will be responsible for the Entry Fee.

Teams will be placed in pools of 8 on the first day. On the second day, the top 16 teams will be placed in a 16-team bracket. The remaining teams will be placed in 4 team pools. This way everyone will get a minimum of 10 matches.
