Madison Weight System for all divisions: Weight classes will be determined at weigh-ins. All wrestlers will have their weight recorded at weigh-ins and will be grouped in 4 Man Round Robin Brackets. The tournament director reserves the right to combine or divide weight classes if needed. No seeding. Age on day of tournament. Proof of age must be available on request.

Round Robin Format

Each wrestler may only wrestle in one division and one weight class

Headgear required. Uniform – One-piece singlet preferred, but tight shorts and tight shirts acceptable

Wrestlers with skin lesions will need a doctor's note that they are not contagious
